I then activated my radar and locked the vehicle (black colored compact car) in at 81 mph. I then got behind the vehicle and activated my blue lights in an attempt to make a traffic stop on the vehicle. The vehicle then pulled into Ricky's Store located on Hwy 32 E. I exited my vehicle and made contact with the driver. After speaking with the driver, I smelled a strong odor of an alcoholic beverage coming from inside the vehicle. The driver admitted to drinking the night before. I then conducted field sobriety tests on the subject and arrested him for driving under the influence and for speeding.
