<p>On November 18, 2016, at approximately 1125 hours, I, Corporal Brandon Haygood, was notified by 911 of two calls at Coffee Regional Medical Center. According to 911, a male at the location was asking for officer 38 and a female was calling about someone harassing her. Upon arrival, I first came in contact with the male who advised someone was trying to fight him. The male was extremely hard to understand. I was able to verify that no one had assaulted him, and that he had walked to the location to use the hospital's WIFI. He explained that his ex-girlfriend's boyfriend was starting problems. I could not understand the male well enough to be able to tell how he was starting problems. He advised he could show me where the female's car was in the parking lot. I advised him that I did not need him to do that and instructed him that if his only business here was to use the hospital's WIFI he should leave the property. He agreed and walked towards the roadway.</p> <p>After speaking with this male, I spoke with his ex-girlfriend's boyfriend. He advised the subject came up to him trying to fight him.</p> <p>Upon speaking with the ex-girlfriend, she advised her relative called her saying that the offender was walking towards the hospital. She then began watching him from a third story window. She advised the offender saw her vehicle and began walking circles in the parking lot. At some point, her boy friend went outside to smoke and was approached by the offender. She advised that the male has been stalking her by leaving notes in her mail box and riding by her house. She also advised he has been talking about her on social media. She said she had previously spoken with a deputy regarding the incident. She could not give specific dates or details of the incidents.</p> <p>While speaking with her, Officer Jose Granados advised he had made contact with the offender in the emergency room. I again spoke with him and told him that he needed to leave the property if he had no business here. He eventually left.</p> <p>I advised the female she should get a copy of the report and get a restraining order on the male.</p>

On November 19, 2016, at approximately 1448 hours, I, Corporal Brandon Haygood, responded to Georgia Carmart in reference to criminal damage to property. Upon arrival, the complainant advised while she was inside the business speaking with a customer someone broke a window on a 2005 Dodge Grand Caravan that was in the parking lot. The complainant advised a customer saw three black males in an older model Jeep Cherokee (grey in color) near the vehicle just prior to finding the damage. She advised she knew the damage was not there before this vehicle arrived. The customer advised the driver of the vehicle was a black male with dreads and was wearing a white tee shirt. The vehicle left and was said to have turned into Kenwood Mobile Home Park. No one at the location saw how the window was broken. The complainant was unable to work the cameras to review footage.					
The aforementioned Jeep Cherokee and the male described as being the driver were later located at 400 Cecil Way. Upon speaking with him, he advised him and his "homeboys" were at the location looking at vehicles when someone shot at them from the roadway. He did not know who the individual was that shot at them. None of his homeboys that were said to be with him was at this location at this time. There was a baseball bat inside of the jeep, however there did not appear to be any pieces of glass on the bat.					
Due to no one seeing what actually happened and video currently being unavailable, no charges have been filed.
