On November 29, 2016, at approximately 0930 hours, I, Corporal Brandon Haygood, responded to the area of Mcdonald Avenue and Ward Street in reference to a single vehicle traffic accident. Upon arrival, I spoke with the driver who advised she was traveling westbound on GA Hwy 32 East (Ward Street). When she approached Mcdonald Avenue, she attempted to turn left onto this roadway. As she turned, she advised it felt like she was going over speed-bumps. This caused her to be unable to remain in control of the vehicle. The front passenger's side tire struck the curb on the right side of Mcdonald Avenue. She advised she nearly hit a light pole, but was able to regain control a few feet from the pole and avoid it. There were visible skid marks where she hit the curb and where she continued afterward. The damage to the vehicle appeared to be limited to the front passenger's side tire and rim. No injuries were reported. Photographs were taken.

On December 4, 2016 at approximately 1323 hours I, Officer Raulson was dispatched to the intersection of Georgia Highway 32 and Shirley Avenue in regards to a vehicle collision. Upon arrival I confirmed that no one was injured and spoke with Driver 2. Driver 2 said that she was waiting at the red light when driver 1 rear ended her vehicle. I spoke with Driver 1 who said that the light was green and he was slowing down, however he believed that Driver 2 was about to go. Driver 1 said that Driver 2 stayed there and he rear ended her vehicle. Driver 2's vehicle had the rear bumper slightly popped out and scratches on the bumper. Driver 1's vehicle had scratches on the front bumper and the bumper was dented on the passenger front wheel, however Driver 1 was able to pulled it back to drive the vehicle. Driver 1's vehicle also had the headlights removed as they were in the roadway.
